



Corporate Preferred Business Class TERMS AND CONDITIONS

1. **Eligible Renters.** TRAC will make vehicles available to employees of Customer on official Customer business who are 21 years of age or older and who have a valid driver's license. All renters are subject to TRAC's standard driver qualification procedures, including a valid driver's license, insurance coverage and a credit card in the renter's own name with available credit, unless Customer is pre-approved by TRAC for direct billing. Except as modified herein, all terms of TRAC's standard rental agreement shall apply.
2. **Payment.** Customer shall pay TRAC all rental fees and associated charges incurred under this Agreement. Daily rates will be billed for each 24-hour time period, weekly rates will be billed for seven twenty-four hour periods and monthly rates will be billed for each 30 twenty-four hour periods.
3. **Corporate Rate Guarantee:** The corporate rates listed in the attached Corporate Rate Addendum will be guaranteed at participating TRAC locations in Houston, Texas (for participating locations, please see (www.rentatoyotahouston.com)) Upon expiration of rates, TRAC may, in its sole discretion, continue to offer the rates stated herein until such time as the parties agree upon a new corporate rate agreement. The rates are based upon Customer's anticipated Expected Expenditure, as defined in the rate addendum. TRAC reserves the right to increase rates and/or benefits under this offer .
4. **Preferred Vendor.** In consideration of the rates and discounts offered in this Agreement, Customer designates TRAC as a preferred vendor of rental cars, and agrees to inform its employees in writing of the rates and benefits offered by TRAC as outlined herein. 5. **Confidentiality.** Customer agrees that it will not publish or permit the publication of, in any manner or media, the existence or terms of this Agreement, any actual or potential business relationship between TRAC and Customer, or the logos or any other intellectual property of TRAC, its affiliates or its customers, to any third parties. Nothing contained herein shall prevent such publication or disclosure to Customer's employees and affiliates.
6. **Termination.** Either party may terminate this Agreement without cause by notifying the other party in writing at least thirty (30) days in advance of such termination.
7. **Terms-** All rates stated above include unlimited daily and weekly mileage. 3500 miles free per month. Rates do not include motor vehicle sales tax (up to 15%), refueling fees, and vehicle licensing fees as required by the State or Texas. Renter responsible for all toll or red light citations obtained during rental period.
