CHAPTER FIVE. Basketball Commissioners

§ 5.01 Basketball Player Representatives.

- (1) There shall be two Basketball Player Representatives, one for men and one for women.

§ 5.02 Appointment, Terms and Voting.

- (1) The Player Representatives shall be appointed by the Men's and Women's Basketball Players Advisory Committee. They shall be entitled to vote at the Basketball Council.

§ 5.03 Duties.

- (a) Report periodically to the Executive Board.

- (b) Develop guidelines on Division I, II, III (I and II for Women).

- (c) Review and verify all basketball players' eligibility per current rules and regulations. Refer to the Board those eligibility situations which might require review from the Board.

- (d) Set up national tournament brackets with schedule of games.

- (e) Recommend team seeding on each division for Board review.

- (f) Recommend and coordinate procedures for scorekeepers, statisticians, timekeepers, trainers, and the all-star selection committee, subject to the approval of the Board.

- (g) Work closely with the National Basketball Tournament Liaison and host committee as appropriate to conduct the tournament.

- (h) Coordinate activities and schedules of the referees with the National Officials Coordinator.

- (i) Evaluate the tournament program and make recommendations to improve future tournaments.

- (o) Work with National Officials Coordinator each year to develop a cost analysis comparing costs of using local or national officials (referees) and make recommendations to the Board for approval.
